

## **Westie Rescue of North Texas ('WRNT') Westie Walk 2013 Pledge Drive Contest Rules**

### How to Enter:

WRNT's Westie Walk 2013 Pledge Drive Contest is open to any individual participant unless the individual participant is prohibited by law from entering. To enter the contest, individuals must raise at least \$250 in the pledge drive, submit their completed Pledge Forms, including checks and/or cash to WRNT. Pledge Forms and monies collected can be submitted either in person or by mail. In person submissions must be submitted to WRNT at Westie Walk 2013 at the registration table on October 12, 2013, by 11:00 a.m. in order to be eligible to win the prize. Those that cannot attend the event may enter the contest by submitting the pledge form and checks payable to "WRNT" by mail to WRNT, 8369 San Cristobal Drive, Dallas, TX 75218. Mail-in entries must be **received** by October 9, 2013 to be eligible for the contest. Only checks made payable to "WRNT" will be accepted for mail-in entries—no cash will be accepted for mail-in entries.

### Prize:

The prize will consist of a 42 inch flat screen TV. No warranty is provided on this prize, and no refunds, cash alternatives or substitutions will be made. WRNT reserves the right to substitute a prize of comparable value if a prize listed is unavailable for any reason. All taxes, duties, fees and surcharges associated with the prize are the responsibility of the winner. The prize will be shipped to the winner after WRNT has confirmed and received the monies collected from the winning participant. The prize will not be shipped until all checks have cleared.

### Selection of Winner:

The person that raises the most money will win the prize, a 42 inch flat screen TV. In case of a tie, the names of the individuals that collected the same dollar amount will be entered into a random drawing. WRNT will randomly select a winner. The winner will be announced at Westie Walk 2013 before the end of the event. The winner must comply with all terms and conditions set forth in the rules. Winning is dependent on fulfilling

those requirements. If the winner is a participant who entered the contest by mail, the winner will be notified via email. WRNT is not responsible for notifications that are undeliverable because of incorrect email addresses. If the winner cannot be contacted within 14 days after the first attempt to contact, an alternate winner will be selected.

Prize is not transferable, assignable or redeemable for cash.
